

# EDEX Expo 2026 - TERMS AND CONDITIONS, EXHIBITION RULES AND REGULATIONS.

Organizer / Exhibitor / The Exhibition

- A) The term 'Organizer' means the organizer(s) of the exhibition which is the EDEX Expo 2026 Organizing Committee.
- B) The term 'Exhibitor' means any organization, company firm or person who exhibit at the exhibition and shall include any labour, staff and agents of any such organization, company firm and person.
- C) The Exhibition means EDEX Expo 2026 higher education and careers exhibition.

Exhibitors shall be bound by the Terms and Conditions Rules and Regulations set forth in this agreement and any changes must be made in writing and signed by an authorized official of the Organizer, who shall have full power to interpret and to make or amend these rules, provided that such amendments and additions do not operate to diminish the rights reserved for the exhibitor under the Request Form/Agreement.

## **SPACE Allocation**

EDEX Expo 2026 Committee will process and allocate demarcated bare space giving due consideration to requests from Event Sponsors (who will receive highest priority),number of years of participation at previous EDEX Expo events (by the applicant), the locations occupied in the past, the total space to be occupied at EDEX Expo 2026 etc.

Their decision with regard to the allocation of demarcated bare space and/or any other matter related to the exhibition shall be final. The Organizer reserves the right to reject any application without offering reasons.

# **Payment**

Once the allocated space is communicated by the Organizer, the non-refundable advance payment applicable should be paid to EDEX and the applicant should enter into a formal agreement within the stipulated timelines.

No reservation can be considered confirmed, unless accompanied by the advance payment and the subsequent payment terms are strictly adhered to. No extensions will be allowed for early bird discount and /or the final payment.

All Cheques are to be drawn in favour of "EDEX Expo" and crossed 'Account Payee Only'. (To be submitted ed only after the official invoice is released to the applicant)

# **Rejection of Participation:**

The Organizer have the right to reject any participation if the exhibitor is considered a late registrant and/or its business nature is not relevant to the Expo topic and/or any other conditions that the Organizer shall consider in appropriate.

# Cancellation, Re-schedule, Re-location:

In case the organizer finds it necessary to cancel the said Expo due to any unforeseen reasons, the Organizer or employees shall not be liable to exhibitors for any loss, damage or delay resulting from such a cancellation.

The Organizer or employees shall not be liable to exhibitor for loss, damage or delay resulting from acts of war, civil commotion, strikes, lock-out, Government intervention or regulations, import or export restriction, any other circumstances which shall make it impossible or unadvisable for the Organizer to hold the exhibition at the time and place provided, the Organizer reserves the right to reschedule the exhibition for a later date. The Organizer reserve the right tore-locate the exhibition.

# **Subletting of Space**

Letting / Sub-letting in whatever manner or form is strictly prohibited, which includes, but not shall limited to the practice of a principal renting/subletting/assigning wholly or in part of its rented space to it agent(s) and business associate(s) and vice versa. The Organizer reserves the right to expel any originally authorized exhibitors on account of such violations. Any cost incurred shall be borne by the contracting party.

#### Name Panel

The name panel should reflect the name of the Exhibitor's institute in full or short form for which the organizer should possess relevant documentary evidence or authorization from the principal in the event of an agency relationship. Any deviations should be with the prior approval of the Organizer.

## Insurance

Whilst we take every precaution to protect exhibitors' movable property during the Event, we will not be responsible for any loss or damage, or injury to persons caused by their installations/equipment, and they must obtain appropriate Public Liability Insurance Cover.

## **Code of Ethics**

All exhibitors attending EDEX Expo must conduct themselves in a manner consistent with the following Code Ethics which is not limited to the EDEX Expo, but are applicable to all activities and events associated with EDEX Expo.

Exhibitors shall at all times themselves conduct with honour, dignity and to promote the advancement of education and/or skills/vocational training of a prospective student.

All exhibitors should possess the ability to provide complete, accurate and authentic information on study programs they showcase. Exhibitors should provide most appropriate options to students based on their academic qualifications and financial standing.

All exhibitors representing Principal Institutes/Universities here and abroad should possess explicit authority for such representation and should be prepared to present related documentary evidence to any visitor, interested party that include the 'Organizer' if called upon to do so.

Canvassing of students for institutes without explicit authority from principles is strictly prohibited.

Exhibitors should be transparent about all fees if any, are to be levied by the local representative. All such fees and any additional charges should be declared to students/parents at the outset.

Undue canvassing and/or handling practices obstructing other participant exhibitors or using audio, visual devices materials to gain unfair/undue advantage are prohibited.

Exhibitors are responsible for the orderliness, placement and upkeep of exhibits in the assigned exhibit areas. Distribution of materials, leaflets to promote institutions'/courses should strictly be confined to the rented booth space only.

No owner, exhibitor, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics.

Consequences to violating this code of conduct may include, but are not limited to:

- 1. Verbal warning
- 2. Written warning
- 3. Removal from Exhibition venue
- 4. Loss of future participation

# Interpretation

The Organizer reserves the right to make changes, amendments and/or additions to the terms and conditions, rules and regulations, and the layout facilities governing the exhibition as and when considered necessary for the proper conduct of the Exhibition. Interpretation of clauses contained herein shall rest entirely with the Organizer, whose decision shall be final and binding.

## **Unforeseen Occurrences**

In the event of any occurrences not foreseen in these Rules and Regulations, the decision of the Organizer shall be final.
